

## DISTRICT OF VANDERHOOF

### BYLAW 949, 2003

A bylaw to amend the Corporation of the Village of Vanderhoof Garbage Collection Bylaw No. 155, 1958, as amended by Bylaws No. 717, No. 885 and No. 916.

The Council of the District of Vanderhoof in open meeting assembled, enacts as follows:

#### 1. User Charges

- (a) That Section 14 of Bylaw No. 155, as amended by Bylaw No. 885 is hereby deleted in its entirety and that the attached 'Schedule A' is substituted therefore.
- (b) That the owner of each and every parcel of real property upon which there is now or hereafter may be situated one or more of the establishments described in the attached 'Schedule A', shall in respect of each establishment pay or cause to be paid to the District for the use of garbage service supplied by the District to or for such establishment or establishments the sum or sums specified in the attached 'Schedule A'.
- (c) That users have the option to opt out of the garbage collection program.
- (d) That there shall be no pro-rating of the annual fee except upon the opening of a new account.
- (e) That, upon application to the District of Vanderhoof, a \$50 reduction may be given for a fewer number of scheduled weekly pickups.

#### 2. Discount

An early payment discount of 10% will be allowed on payments received prior to the close of business on October 31st of each year.

#### 3. Effective Date

This bylaw shall take effect January 1, 2003.

#### 4. Repeal

That District of Vanderhoof Garbage Collection Rate Amending Bylaw No. 916, 2001 is hereby repealed.

#### 5. Citation
